OFS SELLS ITS OSP CLOSURE PRODUCT LINE TO CICADA TECHNOLOGY INC.

The acquisition will enhance Cicada Technology's product offering in OSP fiber cable connectivity. Cicada Technology now owns the physical assets and has a right to use the technical information relating to OFS' OSP Closure product line.

"Our company and our management team have significant experience in fiber optic closures and are totally committed to support our customer base and expand this product line.
